IMPORTANT SAFEGUARDS

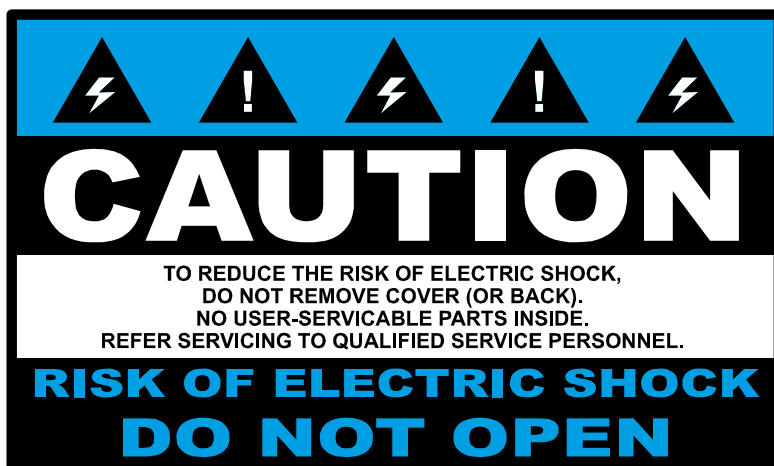

INTRODUCTION

PRODUCT DESCRIPTION

AvertX ProConnect cloud managed recorders are turn-key appliances designed for hassle free, plug-n-play installation. AvertX ProConnect model recorders come equipped with an integrated PoE switch for connecting IP cameras directly to the recorder and come preloaded with AvertX's powerful ProConnect Software recording software.

All AvertX ProConnect recorders are designed for deployment with AvertX Connect, allowing centralized administration of users, permissions, and system settings. These recorders also utilize AvertX's Web Connect technology for single sign-on, roaming profiles, and automated internet connectivity.

SETTING UP THE RECORDER FOR THE FIRST TIME

TURNING ON THE RECORDER

1. Turn on the monitor connected to your recorder.
2. Use the power switch on the rear of the recorder to turn the recorder **ON**.
3. The recorder will run a series of self-tests. If asked to respond to any messages, follow the instructions carefully.

Startup is complete when the login screen is displayed.

TURNING OFF THE RECORDER

1. Click **Setup**, and then click **Power Off / Restart**.
2. Click Power Off.

VIRTUAL KEYBOARD ON THE LOCAL CONSOLE

A virtual keyboard is available for AvertX ProConnect installed on local consoles. By default, the virtual keyboard will automatically appear when the system keyboard is not detected.



When a system keyboard is connected, click the keyboard icon to access the virtual keyboard.

WEB INTERFACE SYSTEM REQUIREMENTS

ProConnect can be accessed locally via the ProConnect Local or remotely via the ProConnect Web Interface. The Web Interface runs in a HTML5 environment, making it compatible with a wide range of browsers and without additional software installation.

Note ProConnect software setup can be performed through the ProConnect recorder local interface or through the web browser Web Interface.

Default Administrator Username / Password

Note Once registered to AvertX Connect, your AvertX Connect credentials can be used to log in, in addition to the default credentials listed above.

First Time Wizard


The First Time Wizard can be accessed from both the web interface and locally and will guide you through a basic setup of your ProConnect recorder. If you wish to make system changes after the initial setup process using the First Time Wizard, these options can be found in System Settings, User Management, and Network Configuration.

The Setup Wizard will run the first time the recorder is powered on.

Default Camera Password

AvertX has improved our default camera password functionality with several new ease-of-use features in software version 2.4. The updates provide administrator level users the ability to define a default camera password, as well as the ability to see previously applied camera passwords.

Change the Default Camera Password

1. Click Setup  > System Settings > Settings > General Settings.
2. Scroll down to Default Camera Password.
3. Change the default password.


Note Passwords must be 9-14 characters and include at least two of the following: one number, one letter or one special character (!#\$%&*).

4. Click **Save**.

Note This feature is only supported for AvertX cameras.

Note This will be used for cameras which require a password on first use. It will not change the password for any camera with the password already set.

View Camera Password History

1. Click Setup  > System Settings > Settings > General Settings.
2. Scroll down to Default Camera Password.
3. Click Show old passwords.

Note A password will only appear in the list of previous passwords after it has been applied to at least one camera.

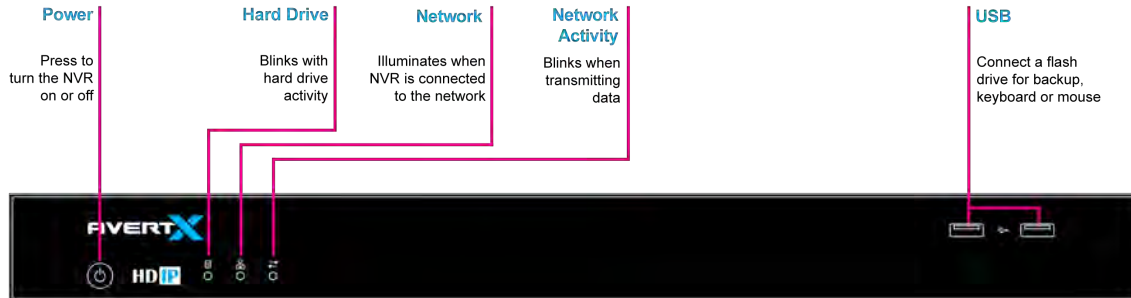

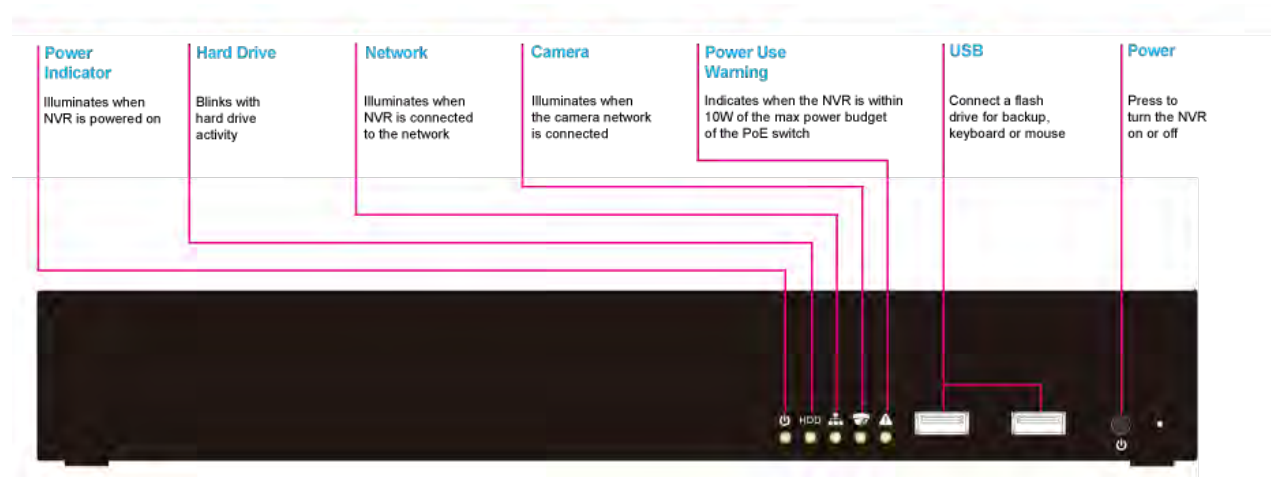

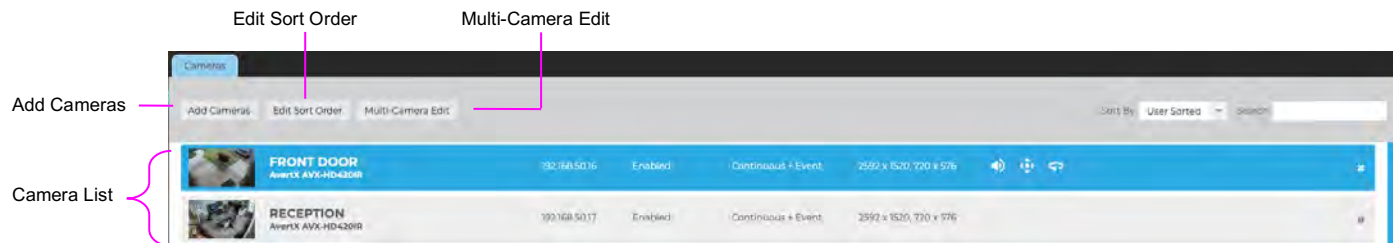

Camera Management

Use Camera Management to perform basic and advanced camera functions.



Camera List – List of cameras currently connected to the selected recorder.

IP Address – The current IP address of the camera.

State – The current camera state.

- Enabled: The camera is enabled, active, and recording.
- Disabled: The camera is disabled, but previously recorded video is still available.

Recording Type – The current recording mode of the camera.

Resolution – The resolutions of the Continuous and Event Video Settings.

Audio Enabled –  Compatible cameras have audio enabled.

PTZ Enabled –  PTZ compatible camera has PTZ enabled.

360° Enabled –  Fisheye camera is enabled.

Add Camera – Add a camera(s) to the Camera List.

Advanced – Launches Network Camera Manager (Console Only)

Edit Sort Order – Change the order the cameras will be displayed in local and remote clients.

Multi-Camera Edit – Delete cameras, update images, change recording types, and other options to multiple cameras at once.

Sort By – Order cameras by State, Name, Model, or IP Address.


Search – Search for a camera in the Camera List.

Delete or Disable [x] – Deleting a camera will remove the camera and all associated video from the recorder. To remove the camera but keep the video, select Mark as Disabled instead.



6. Enter the appropriate credentials (username and password) for the cameras you wish to add, and then click **Add Selected Cameras**.



Refresh – Refresh the camera list to reflect changes.

Add Selected Cameras – Check the boxes to add the cameras selected from the Add Camera list to the Camera tab.

Name – The make and model of the camera.

IP Address – The IP address of the camera.

Subnet Mask – The subnet mask of the camera.

Static/DHCP – Use the dropdown to select between Static IP or DHCP.

Enter Custom Name – Enter a custom name for the camera to make it more easily identifiable.

Username / Password – The necessary credentials to access the camera.

Camera Auto-Discovery


ProConnect recorders automatically configure cameras attached to the onboard PoE switch. Cameras not connected to the PoE switch will automatically be discovered, but need to be configured via the Add Camera menu.



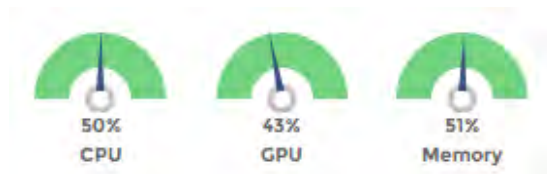

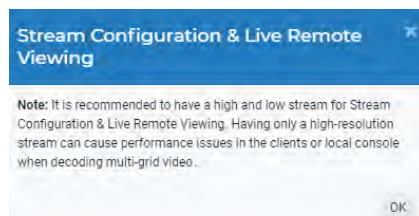
Note If at least one resolution at 720x576 or below is not available, the following warning below will appear.



Server side motion detection is enabled on this camera and for performance reasons a video stream with a resolution between 720x576 and 352x240 is highly recommended. An optimal stream is not currently detected, but motion detection will still continue to function.

Note Smart codec should not be enabled on the secondary stream that is used for video motion detection. For devices using single stream, smart codec should be disabled for video motion detection.

Note It is recommended to have a high and low stream for Stream Configuration & Live Remote Viewing. Having only a high-resolution stream can cause performance issues in the clients or local console when decoding multi-grid video.

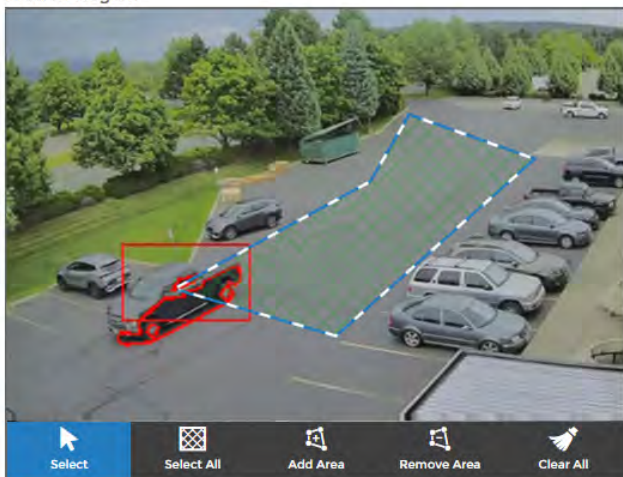

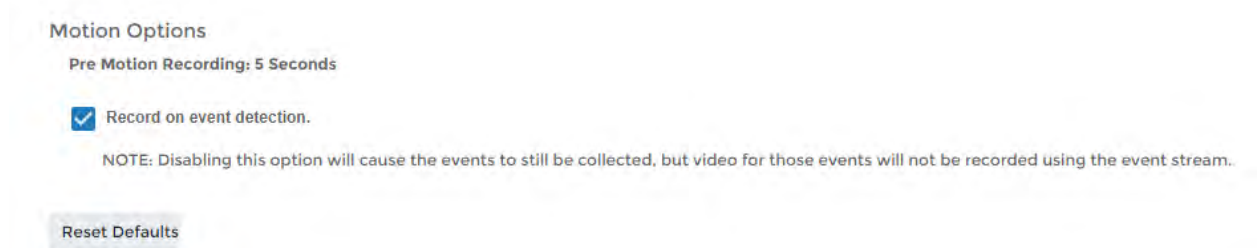

IR Function – Activate the camera IR (infrared) lights if available, for use with night-time recording.

Exposure Mode – Select the correct exposure mode to achieve the desired exposure effect.

Shutter – Select Manual to designate shutter speed. Slower shutter speed will increase visibility at night, but also result in blurred movement in the frame.**

Rotate – Allows the camera to be flipped and/or rotated. Available options vary by camera.

* This option can drastically affect the quality of recorded video. The default value is recommended.

**Using this option results in improved video quality but increases recorded video file size.

Fisheye

Fisheye allows users to de-warp 360° fisheye camera lenses so that a user can pan the camera view in multiple directions even if the camera does not have moving mechanical parts.

Enable Fisheye Support – Enabling this function will enable 360 de-warping for this camera if supported.

Note Video over 9MP will automatically be transcoded to a smaller resolution for performance reasons when Enable Fisheye Support is checked.

Mount Type – Change this setting to Wall or Ceiling based on installation of the camera.

Angle from Vertical – Based on the installation of the camera, enter a number value for the angle of the camera.

Enable Advanced Configuration – This option allows custom tuning of the center and diameter of de-warping done by the software. Adjusting the X and Y Center values changes the position of the warped image in regards to the position of the image as a whole. The diameter value is used to determine the focal length of the lens when calculating de-warp parameters.

Note Supported cameras typically have optimal settings by default and do not need to be modified with advanced configuration.

An exported file can then be imported as needed to restore the configuration options to the saved state, but the AvertX Connect account information is not exported and will therefore need to be manually configured upon import.


Exporting to AvertX Connect restores configuration options to the saved state along with the AvertX Connect account information.

To export recorder configuration settings:

1. Click **Setup** , and then click **Settings**.
2. In the General Settings tab, click Export.
3. When prompted, **Save** the exported configuration file.

Note In the ProConnect Web Interface, the default location to save the .dat archive file is in the Downloads folder.

To import recorder configuration settings:

1. Click **Setup** , and then click **Settings**.
2. In the General Settings tab, Click Complete or Partial Import, and then click Select Import File.
 - Select Complete Restore when restoring to the same recorder or a replacement recorder.
 - Select Partial Restore when using a configuration file as a template for other recorders. Unique Camera Identifiers will not be copied.
3. Navigate to the desired file.
4. Click **Import**.

Note Imports / exports can be performed on both locally and Web Interface. Local exports will require an attached USB storage device.

Export Signing Certificate

Videos and images exported from ProConnect have an embedded digital signature. This is used to validate that these items have not been tampered with.

To validate the files have not been tampered with, you will need the following:

- The image or video file you wish to validate
- The AvertX Digital Signature Verifier (DSV)
- The Certificate Thumbprint from the ProConnect recorder

Note The DSV is a small utility that allows you to validate that the file has not been tampered with. This utility can be downloaded from avertx.com.

Note The thumbprint is a value derived from the certificate that uniquely identifies it; specifically, it is a SHA-1 hash of the certificate.

The DSV utility will attempt to verify the exported file, and then present one of two findings:

- Digital Signature Validated: the Thumbnail for the ProConnect recorder will match the Thumbnail displayed for the validated file.
- Digital Signature Invalid: this indicates that the file does not contain a valid certificate.

Encrypt Relayed Video

This option encrypts video sent using relay.

Legacy Flash Player


This option will enable the Adobe Flash Player instead of the HTML 5 Player for all Users connecting to the recorder.

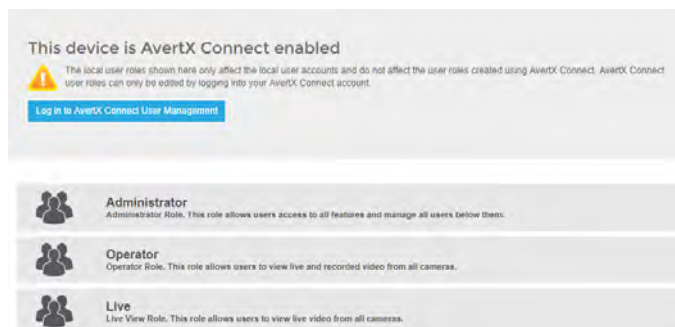

If the device is AvertX Connect enabled, it will be necessary to log in to AvertX Connect User Management to manage users who have access to the recorder. Manually Ping Address

Manually ping an internal or external IP address.

Edit Ports

The ports used to connect to the recorder can be modified.


Video Streaming

Designate the video streaming transport type for global IP network traffic: TPC or UDP.

Bandwidth Management

Enabling Bandwidth Management restricts the amount of bandwidth this recorder can use when sending video to remote clients. This option does not impact users on the local area network.

To enable Bandwidth Management:



1. Click **Setup** .

3. Check **Enable** in the Bandwidth Management section.

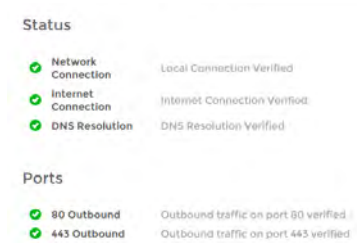

Note The Ext Switch Network Port is not available on all ProConnect models.

Diagnostics

The diagnostics tab shows the operational status of various connections, ports, and relays for your recorder. This is a helpful tool for troubleshooting.



Network Connection – Test pings the local gateway setup on the recorder. In some cases, this may fail if internal ICMP is disabled on the firewall/router. In these rare cases a red X may appear, but service may work without issue.

Internet Connection – Test pings an IP (8.8.8.8) to see if internet connectivity is working correctly.

DNS Resolution – Check to ensure you can resolve DNS names.


80 Outbound – Check to ensure that network traffic can flow through port 80.

443 Outbound – Check to ensure that network traffic can flow through port 443.

Power Over Ethernet

Power Over Ethernet (PoE) allows you to disable automatic add and record for PoE cameras, as well as power cycle individual ports, which will reset the connected camera.

To disable Power Over Ethernet:

1. Click **Setup** , and then click the **Networking** menu.
2. Click the Power Over Ethernet tab.
3. Uncheck the **Enable Plug and Play** checkbox.

—OR—

Uncheck the **Enable PnP** checkbox for the desired camera.

To power cycle the PoE camera: Click the **Cycle Power** icon in the row for the desired PoE camera.

Certificates

The certificates tab allows users to harden security by importing a security certificate for local connections. Users are able to import their own certificate, signed by a public or internal certificate authority, replacing the self-signed certificate that ships with the recorder. Users can view certificate details, upload an existing certificate, or generate a new self-signed certificate if needed.

4. Click **Remote Connections**, and then click to enable connection types. Enter the **external IP** or **DNS** entry for the router in the **IP Address or Domain** field, and **80** in the **Port** field if **Direct Connect** is enabled.

Note Port 80 is the default port.

5. Click **Save**.

LIVE SCREEN VIEWING PANE

The Live screen displays the camera list and live video. Customize the Live screen to view specific cameras in different layouts.



Camera List – List of connected cameras, these cameras can be dragged into a camera tile to display live video.

Note The recorder local Live Screen does not display the Camera List.

Camera List Search – Manually type in the Camera List Search field to filter Camera List by camera name.

On-Screen Display (OSD) – Displays the resolution, video format, bit rate, and frame rate of the camera. **Camera Name**, **Diagnostics Information**, **Recorder Date**, and **Time** can also be displayed in the OSD.

Camera Tile – Individual tile for viewing live video from one camera.

Viewing Pane – Comprised of camera tiles and makes up the viewing space in the Live Screen

Full Screen – View live video in full screen mode.

PTZ – Enable / Disable control of Pan-Tilt-Zoom (PTZ) functions in live view.

Stream – Designate the stream quality for cameras in the Viewing Pane.

Note Available stream quality selections in Live view is based on the selected Grid.

View – Drop down selection of Live video viewing options (4:3, 16:9, original (displays original aspect ratio of all cameras) and stretch (stretches camera images to fit Camera Tile).

Grid – Designate a screen division (1, 2, 4, 6, 8, 9, 10a, 10b, 10c, 13, 16, 17, 25) to view live video from cameras in the viewing pane.

NAVIGATION BAR



Live – Display Live video in the viewing panes.

Search – Playback recorded video in the viewing panes.

Setup – Access the General Configuration, Remote Services, and Tools/Logs menus.

Feedback – Submit feedback directly to AvertX.

About – View version and copyright information.

RIGHT-CLICK MENU

Right-clicking on a live camera tile while viewing live or recorded video will display the right-click options menu.

OSD – On-Screen Display (resolution, video format, bit rate, and frame rate).

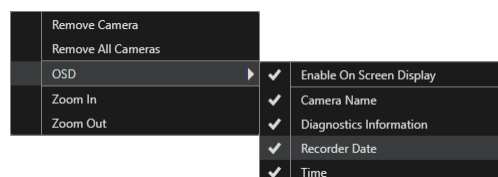
Remove Camera – Remove camera from the current Live Screen viewing pane.

Remove All Cameras – Removes all cameras from the current Live Screen viewing pane.

OSD – Check **Enable On Screen Display** to display the resolution, video format, bit rate, and frame rate of the camera. In addition, check to view **Camera Name**, **Diagnostics Information**, **Recorder Date**, and **Time** in the OSD.

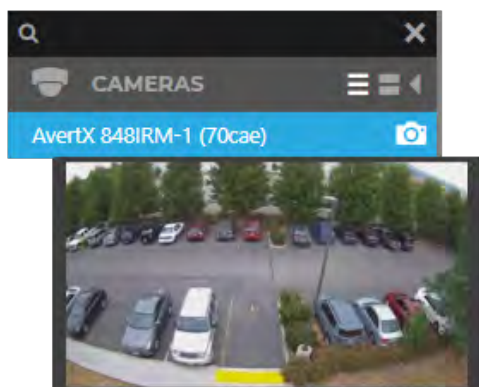
Zoom In – Click to zoom in on a camera image.

Zoom Out – Click to zoom out of a camera image.

How Do I Add / Remove Cameras from The Live Screen Display?

Add Camera

1. Click and drag a camera from the **Camera List** to the **Viewing Pane** to create a **Camera Tile**.

Note Change the Live screen **grid** if more camera channels are desired.

—OR—

2. Click the desired camera on the **Camera List** to automatically add it to the **Viewing Pane** in an available **camera tile**. Each subsequent camera clicked will be added to the next available **camera tile**.

—OR—

3. Drag one **camera tile** over in the **Viewing Pane** to swap their locations.

Add All Cameras

Click and drag the **Camera List** header to the **Viewing Pane** to load all cameras in live.

Remove Camera

1. Right-click in the desired camera tile to display the **right-click menu**, and then click **Remove** or **Remove All**.

—OR—

2. Move the mouse to the top of the camera tile to display the **tile toolbar**, and then click the **red 'X.'**

How Do I Collapse the Camera List?

Click the arrow on the **Camera List** header to collapse and expand the Camera List.

How Do I Manually Cycle Through Camera Views?

Use the Left and Right arrows at the sides of the Viewing Pane to manually cycle through camera views.

How Do I Adjust the Grid of Camera Tiles in The Viewing Pane?

The Live screen display can be adjusted to show live video for 6, 8, 9, 10a, 10b, 10c, 13, 17, 25 camera tiles.

1. In the Live screen, click **Grid**.
2. Click on the desired **screen grid**. The screen grid will automatically apply.
3. Adjust the **camera tiles** to display the desired cameras.

How Do I Adjust the Live Screen View?

The Live screen view affects the camera tiles and the aspect ratio / format of the live video being displayed.

1. In the Live screen, click **View**.
2. Click the desired **view**. The Live Screen view will automatically apply.

Note Choose from aspect ratios of 4:3 or 16:9, and choose a format of Stretch or Original.

How do I Adjust the Live Video Stream Quality?

The Stream Quality option affects the resolution of live video as seen on the Live Screen. The stream resolution can be set to low, medium, high, or automatic.

1. In the Live screen, click **Stream**.
2. Click the desired **streaming resolution (Low, Medium, High, or Auto)**. The Live Screen will automatically adjust.

Note The available streaming resolutions are dependent on camera setup.

How Do I Enable and Control PTZ?

1. In the Live screen, click **PTZ**.
2. Select the **PTZ camera**.
3. Hold the left mouse cursor down on the video pane and drag the arrow icon to move.

How Do I Enable Fullscreen?

1. In the Live screen, click the **Fullscreen** icon.
2. Click the **Fullscreen** icon again to disable.

How Do I Turn the OSD ON / OFF?

The On-Screen Display (OSD) shows the video resolution, video format, bitrate, and frames per second on top of the live video feed. The OSD can be turned on / off per-camera or for all cameras.

Toggle OSD for All Viewing Panes

Right-click on any viewing pane to display the **right-click menu**, and then click **OSD**.

Toggle OSD Per-Camera

Move the mouse to the top of the desired viewing pane to display the **pane toolbar**, and then click **OSD**.

Digital Zoom

Digital zoom can be used in the Live screen or the Search screen.

Note Digital Zoom is currently only supported in the ProConnect Web Interface.

1. Click to select the desired **Camera Tile**.
2. Use the scroll wheel on your mouse to scroll up, zooming in.
3. Scroll down to zoom back out.

Note Layouts will save Digital Zoom settings.

HOW DO I DEWARP 360 CAMERAS?

360 cameras can be dewarped using ProConnect. These cameras display in 360 mode by default, but three additional views are available.

To dewarp a 360 camera:

1. On an applicable 360 camera tile, right-click to display the **right-click menu**.
2. Click **360 View Mode**, and then select a mode.

The camera tile will automatically update to reflect the selected 360 View Mode.

360 Camera Dewarping Views

Interactive – dewarping method that allows for interactive video viewing; click-and-drag cursor available to adjust the camera view across the entire 360 view.

360 Panorama – dewarping method that cuts the 360 image at one point and lays the video flat; view the entire 360 view from left to right.

2 x 180 Panorama – dewarping method that shows the 360 image in two split 180 degree views.

Note All 360 dewarping modes enable **Zoom**. Use the scroll-wheel to zoom in and out of the camera view.

PERFORMING A SEARCH

Perform a Timebar Search or a Preview Search to review recorded video, including playback and export of images and video clips.

Note Timebar and Preview Searches are currently only available in the ProConnect Web Interface.

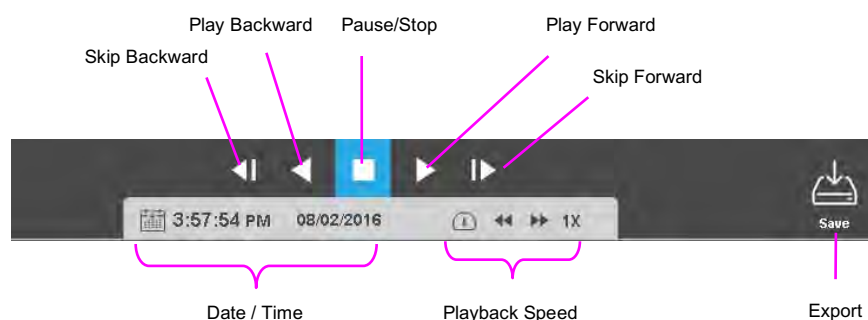
- Date/Time Search – standard search feature available only through the local recorder.

Four different searches are available in ProConnect software:

- Timebar Search – Advanced Date/Time search with visual tools. Only available through the ProConnect Web Interface.
- Thumbnail Search – Advanced Thumbnail-based search. Only available through the ProConnect Web Interface.
- Event Search – Advanced event-based search. Only available through the ProConnect Web Interface.
- Motion Search – Advanced motion-based search. Only available through the ProConnect Web Interface.

How Do I Perform a Date / Time Search Via a Recorder?

Date / Time Search Bar Playback Controls



Add Camera(s) to the Date / Time Search Viewing Pane

When the Search Screen is opened, the cameras that were in the Viewing Pane in the Live Screen will appear, however, cameras can be arranged separately in the Search Screen to facilitate the desired search.

To add cameras to the Search Screen:

1. In the Search Screen, click a camera in the **Camera List**.

—OR—

2. Click and drag a camera from the camera list to the **Viewing Pane**.

—OR—

3. Click and drag the **Camera List** header to the **Viewing Pane** to load all cameras in Search.

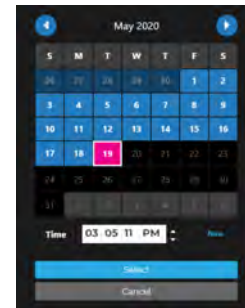

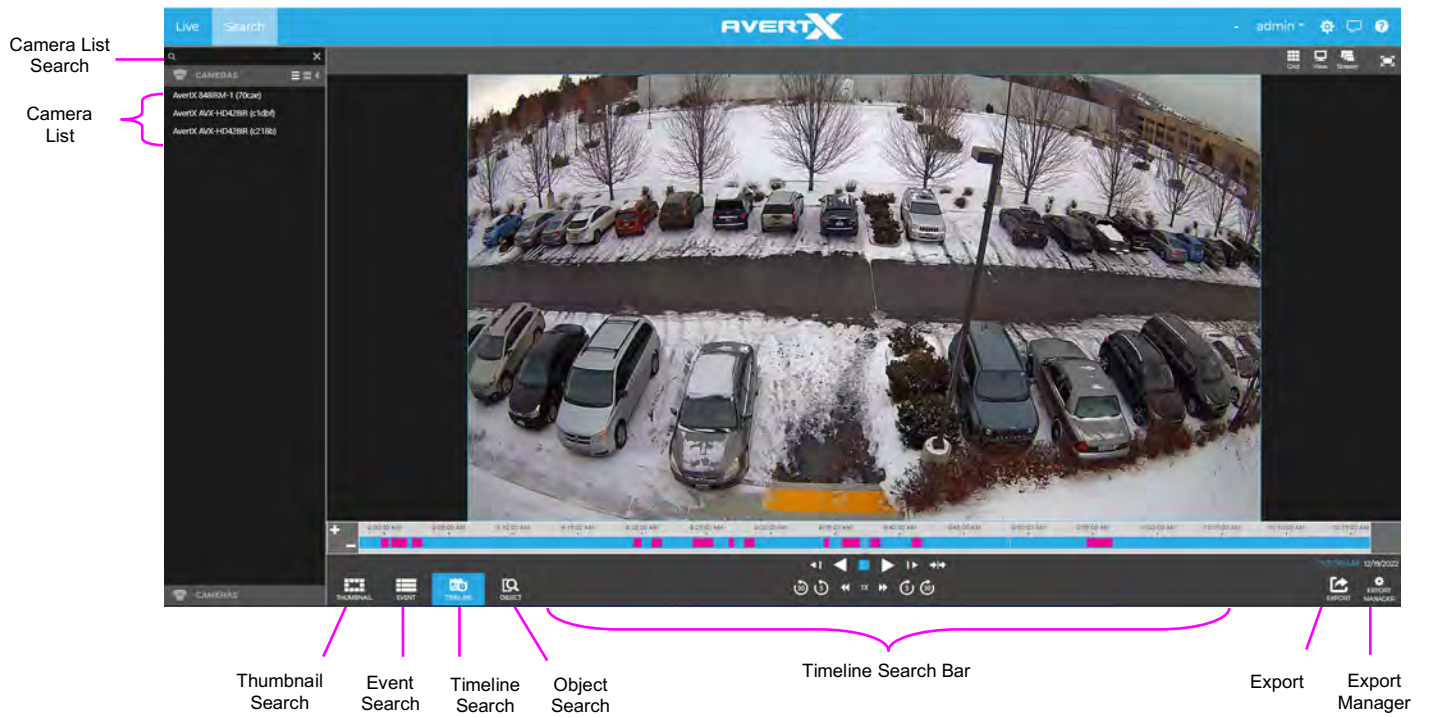

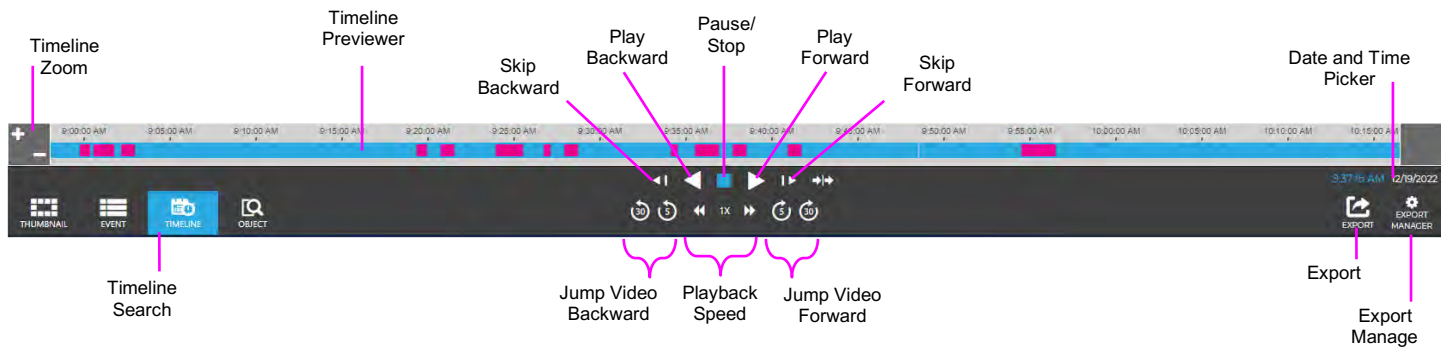

Timeline Search Bar Playback Controls



Note The example Timeline Search Bar shows recorded video that is based on Continuous + Motion recording, meaning the higher resolution motion video is only recorded when a motion event is triggered. This results in video automatically switching between the lower resolution and higher resolution video. Motion video is shown in magenta, and non-motion video is shown in light blue.

Timeline – Continuous recording is represented by light blue lines on the Timeline Search bar, with magenta lines on the Timeline Search bar representing Motion events.

Timeline Zoom – Increases or decreases the amount of time shown in the timeline. Allows for greater accuracy in timeline movement.

Skip Backward – Move to the previous frame of recorded video.

Play Backward – Play recorded video backward.

Pause / Stop – Pause / Stop video playback.

Play Forward – Play recorded video forward.

Skip Forward – Move to the next frame of recorded video.

Jump Video Backward – Jump video backward in 5 or 30 second intervals.

Playback Speed – Control the speed of video playback.

Jump Video Forward – Jump video forward in 5 or 30 second intervals.

Timeline Previewer – Hovering over the timeline will show a preview of the recorded video.

Export – Export recorded video as seen in the current search playback.

Date and Time Picker – Use to designate a date and time to search recorded video.

Timeline Keyboard Playback Controls

In addition to the Search Bar Playback Controls, the keyboard can be used to control some playback functions.

Space Bar – Play/Pause recorded video.

Left Arrow – Reduce playback speed.

Right Arrow – Increase playback speed.

Left Arrow (When Paused) – Move to the previous frame of recorded video.

Right Arrow (When Paused) – Move to the next frame of recorded video.

Add Camera(s) to the Timeline Search Viewing Pane

When the Search Screen is opened, the cameras that were in the Viewing Pane in the Live Screen will appear, however, cameras can be arranged separately in the Search Screen to facilitate the desired search.

To add cameras to the Search Screen:

1. In the Search Screen, click a camera in the **Camera List**.

Customize the Camera Tile Layout

Changing the layout of the viewing pane allows for viewing multiple cameras. All cameras will begin playback of recorded video at the time designated on the horizontal Timeline Search Bar.

1. Click the **Grid** button.

3. Assign the available cameras to the desired camera tiles.

Perform a Timeline Search

Customize the camera tile grid in the Search Screen Viewing Pane if desired.

Select a Date (and Time) from the **Timeline Search Date Picker**.

On the Preview Search Bar, click the **Timeline Search Date Picker**.

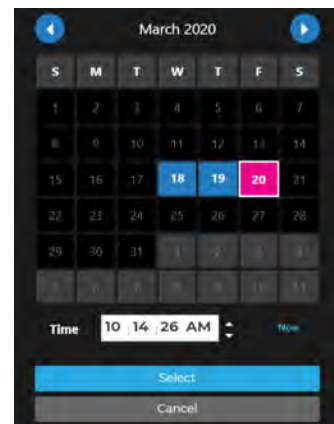
Select the desired **Date (and specific time)**, and then the timeline will update automatically.

Use the **Play/Pause**, **Stop**, **Play Forward/Backward**, and **Skip**

Forward/Backward playback controls to control video playback during your search.

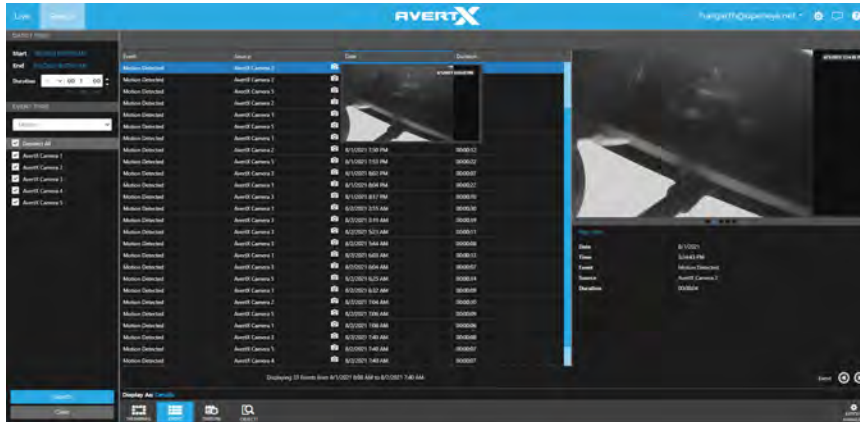

How do I Perform an Event Search (Web Interface Only)?

Event Search is ideal for reviewing sensor or relay events such as motion in a filtered, easily consumable format.



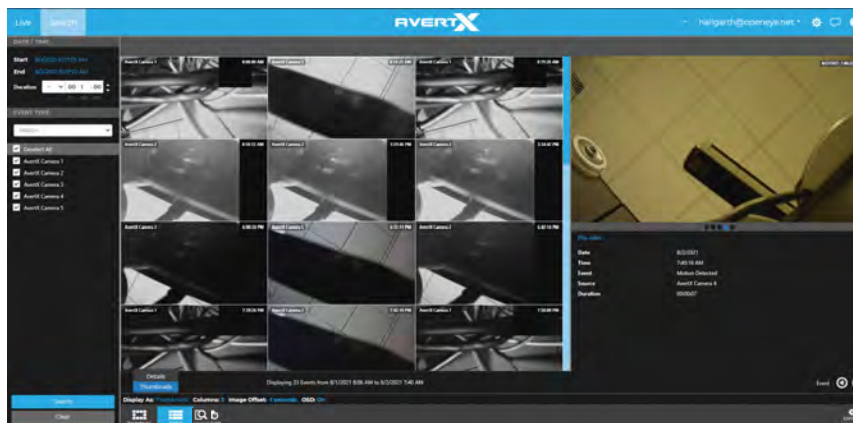

2. Select an **Event Type** from the list.
3. Click **Search**.
4. Select an **event** in the event table to review.
5. Click the **preview image** and the **play icon** to review this video in Timeline Search.

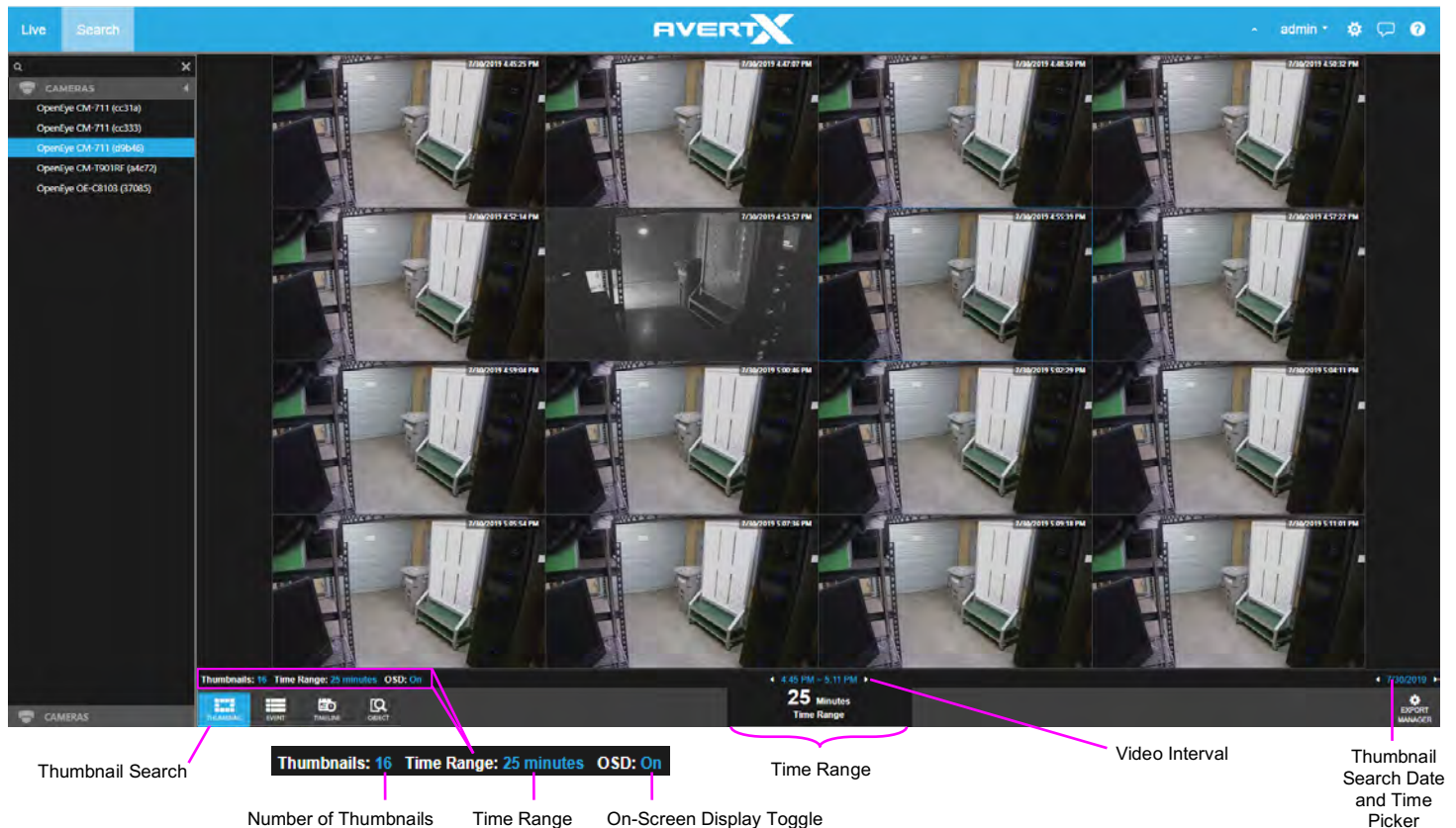
Note Hitting the back button on the browser in timeline search will load the previous event search results when switching between the two.

Change to Thumbnail View

1. Click **Details** on **Display As:** below the event table.
2. Select **Thumbnails** from the menu.
3. The event table will display as Thumbnails.
Customize the number of Thumbnail **Columns** displayed.
Change time of display results between event and image from **-4 seconds to 4 seconds** in **Image Offset**
Turn On Screen Display (**OSD**) information **On** or **Off**.



How Do I Perform a Thumbnail Search (Web Interface Only)



Preview search is ideal for viewing before and after comparisons at user-determined intervals. This search can help a user narrow down a time period during which something changed in the scene, such as vandalism or theft.

Thumbnail Search Bar Playback Controls

The Preview Search bar displays the number of Thumbnails displayed in the Viewing Pane, the Time Range interval between the first and last Thumbnail, and the overall Video Interval.

Number of Thumbnails – Number of Thumbnails distributed across the Time Range.

Time Range – Time interval between the first and last Thumbnail.

On-Screen Display Toggle – Toggle the on-screen display on or off during search.

Video Interval – Display of the exact start and end time for the designated interval.

Thumbnail Search Date and Time Picker – Calendar display tool for choosing Thumbnail Search Dates.

Perform a Thumbnail Search

1. Select a camera from the **Camera List**.

Note Thumbnail Searches allow for only one camera displayed at a time.

2. Select a Date from the Thumbnail Search Date Picker.
 - a. On the Thumbnail Search Bar, click the **Thumbnail Search Date Picker**.
 - b. Select the desired **Date**, and then the Thumbnails will update automatically.
3. Select the **Number of Thumbnails**, the **Time Range**, and turn the **OSD On / Off** as desired.


Note Your combination of Thumbnail quantity and time range will determine the time interval between each snapshot displayed. For example, 25 Thumbnails in a 24-hour time range will result in 1-hour time intervals between displayed pictures.

4. Left-click on the desired Thumbnail to narrow the time interval, opening new Thumbnails.

Note When the Thumbnail is narrowed to the smallest time interval, left-clicking again will begin recorded video playback in the Timeline Search Screen.

5. Right-click the desired Thumbnail to expand the time interval, opening new Thumbnails.

How Do I Perform a Motion Search (Web Interface Only)



Display As: – Display search results as Thumbnails or as a list.

Columns – Display Thumbnail results in **1, 2, 3, 4** or **5** columns.

Image Offset – Change time of display results between **-4 seconds** and **4 seconds**.

OSD – Turn On Screen Display information **On** or **Off**.

Motion Search Region

Perform a Motion Search

1. Under Cameras, select a camera that displays the object in motion to search.
2. Draw a Motion in Search Region in the Preview Window:
 - Left click and drag to create a rectangular Motion Search Region
 - Left click, release, and move to draw a custom polygonal shape one line at a time. Draw and click the last line to the starting point to complete the Motion Search Region.



- Right click to clear a shape.
3. Under Date / Time, select the **Start**, **End** and **Sensitivity** for the search.
Click **Search** to apply the filters.
Click an Event result to preview.
Click the image or **Play video** to review this video in Timeline Search.

Note Hitting the back button on the browser in timeline search will load the previous event search results when switching between the two.

How Do I Export from Search?

Note Exports during Search are only available from the Timeline Search Screen. Thumbnail Searches must be narrowed to the Timeline Search Screen before an export is possible.

- During a Timeline Search, you have the option to export an image or a video clip.
- Resulting image files can be saved locally.
- Resulting video files can be saved locally OR remotely to your AvertX Connect account where they can be viewed and managed remotely.

Export Snapshot (Still Image) Locally

1. In the Search Screen, perform the desired **Timeline Search**.
2. Click **Save**.
3. In the Snapshot tab, enter a **Filename**.
4. Click **Export**.

Note Locally exported images are saved in the **Downloads** folder as **JPEG files**.

Export Video Clip Locally

1. In the Search Screen, perform the desired **Timeline Search**.
2. Click Export.
3. Choose Single Export or Multi Export.
4. Select Cameras to include in the **Multi Export**.
5. Select **Duration** by hours, minutes and seconds or by **Start** and **End** time.
6. Set **Video Quality** along the **Low** and **High** slider.
7. Choose between Mobile Compatible and Original for Video Resolution.
 - Mobile Compatible exports video in 1080p unless the primary recording stream is already at a lower resolution.
8. Check **Audio** if available.

Note Larger **Duration** and higher **Video Quality** will result in larger video files.

9. Click **Next**.
10. Enter Filename and Export.

Note Locally exported video clips are saved in the **Downloads** folder by default as **MP4 files**.

Note Locally exported video clips are saved in the **Downloads** folder by default as **MP4 files**.

Export Video Clip to Cloud

Exporting a video clip remotely saves the clip in your AvertX Connect account. For more information regarding viewing exported video clips, see the *How Do I View Exported Video Clips in AvertX Connect?* section.

1. In the Search Screen, perform the desired **Timeline Search**.
2. Click **Export**.
3. Designate the **Duration**, **Video Quality**, **Video Resolution** and **Audio**, and click **Next**.

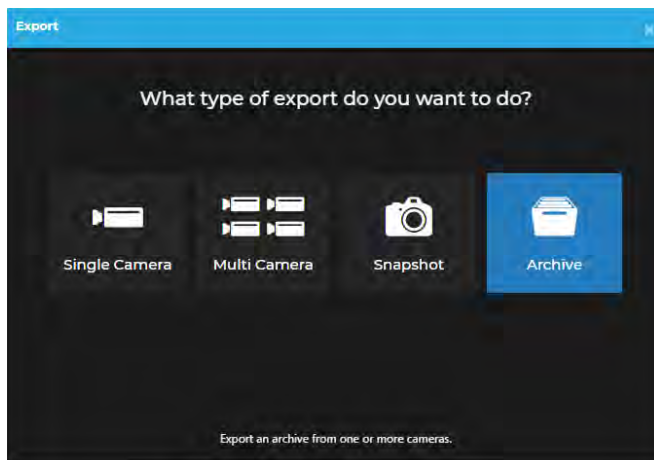
Note Larger **Duration** and higher **Video Quality** will result in larger video files.

4. Type the desired **Title** and **Description**.
5. Click **Export**.

Export Archives Locally

Note Local exports will require an attached USB storage device. ProConnect will only recognize USB storage devices in NTFS, ExFAT or FAT32 formats. Apple users are recommended to use ExFAT format for best compatibility.

1. Make sure the USB device is plugged into a USB port of the recorder. Blue USB 3.0 ports on the recorder are recommended for faster archives.
2. In the Search Screen, select the cameras to archive.



3. Click the **Export** option and select **Archive**.
4. Channels added in search will be automatically selected, uncheck any channels not needed and click **Next**.
5. Set the start and end time of the archive and click **Next**.
6. Click **Select Destination** and select the USB device.
7. Enter the name of the archive in the **Filename** field and click **Export**.

Note Local Console archives provide a standalone Archive Viewer on export to a USB device

How Do I Export Video from the Console with No OSD?

Video can be exported without the On-Screen Display information.

1. In the Search screen, perform the desired **Timeline** search, and then click the **Save** button.
2. Select the **Video Clip** export icon.
3. Specify the Duration and Video Quality.
4. Uncheck **Display Date/Time** on video.
5. Select Destination.
6. Click **Export**.

How Do I Create an Archive?

The Archives function exports up to 24 hours of data in the native format.

1. Add cameras to the search **Grid**.
2. Click the **Export** button and select the **Archive** option.
3. Check the cameras listed and click **Next**.
4. Set the **Start & End Date/Time** and click **Next**.
5. Chose the local or network location by clicking the folder icon and click **Export**.

How Do I View an Archive?

The Archive function displays video in the native format one recorder at a time.

1. In timeline search or the standalone viewer click the **LOAD** option.
2. Navigate to the archive var file, select the file and click **Open**.

Note The stand-alone archive viewer will automatically load the latest var file if located in the same directory.

How Do I Export from an Archive?

Video Clip

The Archive Viewer supports exporting single camera MP4s locally.

1. In the Search screen, perform the desired **Timeline** search, and then click the **Export** button.
2. Select the **Single Camera** export icon.
3. Specify the **Start / End time** and **Video Quality**, and then click **Next**.
4. Select the **Export Locally** option and browse to the desired location, and then click **Export**.

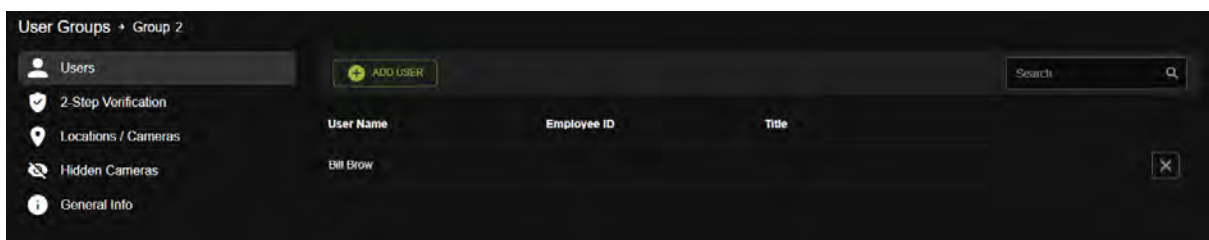
User Groups are classifications which grant users permissions to access various aspects of the account. Accounts have three User Groups: Administrator, Super User, and User. These default groups cannot be edited, and it will be necessary to create a new User Group to choose recorder/camera access for users in the group. To view and make changes to a User Group (other than a default one), click **Edit** next to the desired User Group, or Create a New User Group.

Set up user groups to manage your users by job description and level of access. Health Alert Notification Thresholds

Health Alerts provide notifications after a pre-determined amount of time. Unlike other alerts, the Health Alerts time thresholds are not user-modifiable.

On a correctly configured unit, alert notifications are sent after the following threshold criteria has passed:

- Video Loss - 6 hours
- Recorder Not Reporting - 12 hours
- Recorder Not Recording - 12 hours
- Missing Hard Drive – Instant to 1 hour (Possibly longer depending on the amount of alerts being generated/sent by the unit).

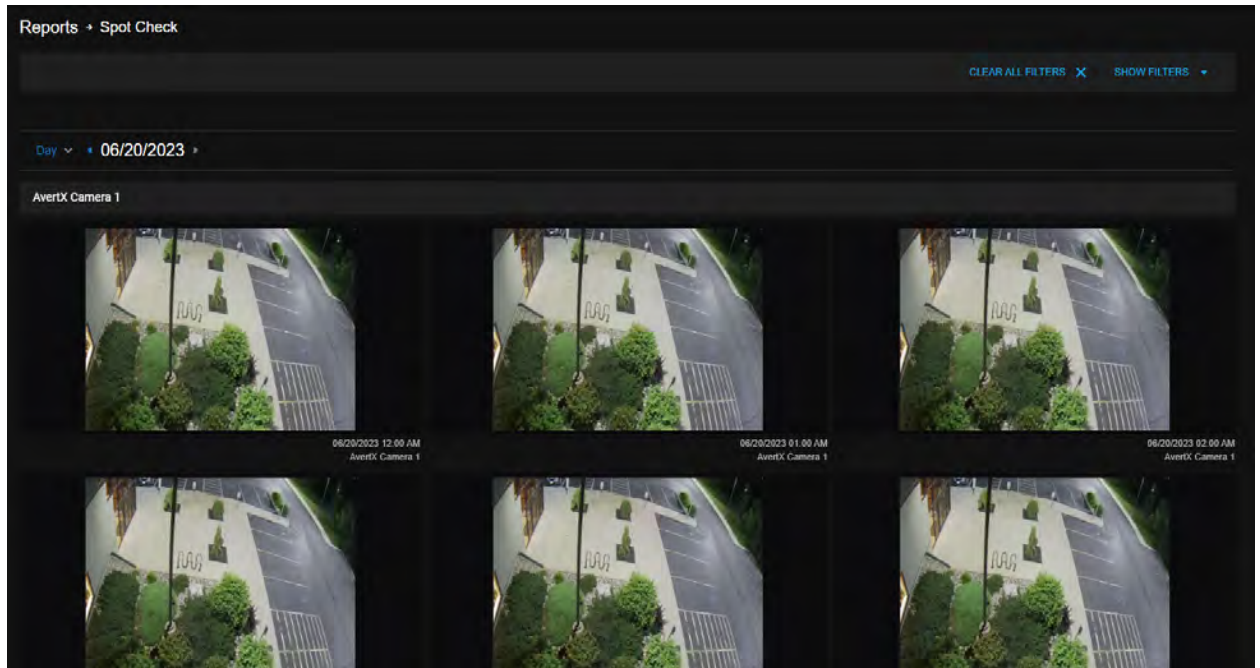

USER GROUPS

User permissions in AvertX Connect are now granted based on User Groups. Instead of assigning each user to Admin/Super User/User, you simply assign the user to a user group, which has pre-defined permission levels.

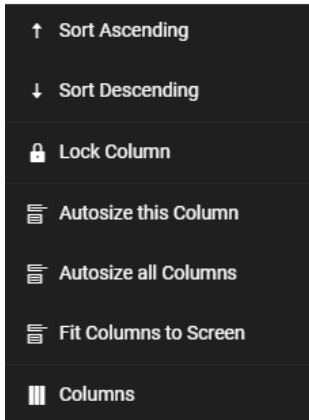

TABLE FUNCTIONALITY

Throughout AvertX Connect, you can customize tables to meet your operational needs. Mouse over the headers and click on the three dots in the right-hand corner.



The different options include:



- **Sort Ascending**- Ascending order means the smallest first or earliest in the order will appear at the top of the list.
- **Sort Descending**- Descending order means the largest or last in the order will appear at the top of the list.
- **Lock Column**- prevents editing or deleting any data in that column.
- **Autosize this Column**- looks at the rendered cells and works out the width based on what it sees.
- **Autosize all Columns**- looks at the rendered cells and works out the width based on what it sees.
- **Fit Columns to Screen**- All columns to fit onto your screen.

When you click on **Columns** at the bottom of the menu it displays all the headers. This section allows you to pick and choose what headers you want to include. Simply uncheck the box if the column is not desired and click Save. To bring the column back, simply check the box to add and click Save. Or default to return to the original choices.
